CQC is a grassroots volunteer-driven organization with a dedicated team of volunteers across Canada. CQC has a small staff team of 5 FTE primarily based in Toronto.

### **Opportunity Overview**

The Medical Coordinator reports to the Senior Director, Operations and Strategy and is responsible for overseeing medical care across our summer camps. This includes supporting and supervising Regional Medical Coordinators (RMCs), delivering training, and ensuring compliance with medical protocols and camping standards. The role involves travel with the Support Travel Team during the summer to provide on-site medical oversight. The ideal candidate will have strong leadership, communication skills, and experience in healthcare settings, particularly in pediatrics and oncology.

#### Responsibilities

#### **Volunteer Support:**

- Provide support to Regional Medical Coordinators (RMCs) to ensure consistent delivery of high-quality medical care across all regional teams.
- Act as the primary point of contact and support for RMCs, addressing questions, challenges, and unique medical scenarios.
- Conduct regular check-ins with RMCs to evaluate their needs, gather feedback, and provide solutions.

### **Training and Development**

- Develop and deliver comprehensive training programs for RMCs and other camp volunteers on medical protocols.
- Organize ongoing education sessions and workshops to ensure RMCs remain current with best practices, regulatory requirements, and emerging medical considerations.
- Create and update training materials, medical guidelines, and resources to support regional teams.

## **Medical Oversight and Policy Development**

- Develop, implement, and maintain standardized medical policies and procedures that comply with provincial and federal healthcare regulations and align with camping association standards (e.g., Ontario Camps Association, Children's Oncology Camping Association, or other provincial bodies).
- Collaborate with RMCs to ensure consistency in medical care, documentation, and operational alignment with accreditation standards.
- Conduct periodic audits of regional medical operations to identify opportunities for improvement and to ensure compliance with all relevant standards.

### **Camper and Program Support**

- Support RMCs in reviewing camper and volunteer medical forms, identifying needs, and addressing risks prior to camp sessions.
- Provide direct consultation or assistance during escalated medical emergencies or complex situations during camp programs.
- Act as a liaison for parents and guardians regarding health concerns or questions about their child's participation in the program.

#### **Administrative Duties**

- Maintain detailed and confidential records of medical incidents, volunteer training completion, and feedback.
- Contribute to post-camp evaluations and collaborate with the Support Centre team to refine policies and processes.
- Assist with recruitment, onboarding, and orientation of new RMCs to ensure regional teams are well-supported.

## **Summer Travel:**

- Join the Support Travel Team during the summer, visiting camp locations across Canada to provide on-the-ground support for RMCs and their medical teams.
- Assist with the delivery of high-quality medical care and ensure medical protocols are followed consistently across all camp locations.
- Collaborate with regional teams to address in-person medical and logistical challenges and provide hands-on training as needed.
